



#### **COVID-19 Test Collection Sites**

- COVID-19 Test Collection Site at Regency Square Mall SEARS, 9501 Arlington Expressway, Jacksonville, FL 32225
  - o Open to St. Johns County residents and anyone that would like to be tested.
    - Must have Identification

This site will operate from 9 a.m. to 5 p.m. seven days a week, for as long as supplies last. While a doctor's order and appointment are not required at this location, clients will be evaluated by a medical professional on site.

- Coronavirus Test Collection Sites in St. Johns County are as follows:
  - o Flagler Health+, 400 Health Park Blvd, St. Augustine, FL 32086 Parking Lot B
    - The Testing Site will be open from 7:00 11:00 a.m., or until the maximum number of daily tests are collected, Monday, Wednesday, and Friday.
    - Testing is available for all ages, and patients do not need to exhibit symptoms, possess a doctor's note, or make an appointment. A parent or guardian must be present for children under 18 to be tested.
    - While insurance cards are not needed, a photo ID is required.
    - Testing is available at no charge

- Florida Department of Health in St. Johns County (DOH-SJC) -St. Johns County Health & Human Services Building, 200 San Sebastian View, St. Augustine, FL 32084. (904) 209-3250
  - As part of disease control investigations, DOH-SJC is collecting specimens for COVID-19 laboratory testing. As part of disease investigations, specimen collection is by appointment-only for those individuals who meet the CDC criteria for testing. For more information about COVID-19 and testing, the Florida Department of Health in St. Johns County's COVID-19 Call Center is open seven days a week from 8:00 a.m. to 6:00 p.m. and can be reached at 904-209-3250. Calls received outside of standard business hours will be redirected to a DOH-SJC Public Health Nurse.

  - Open to the public from 8:00 a.m. 8:00 p.m., Monday through Friday, and from 8:00 a.m. to 5:00 p.m., Saturday and Sunday, as a COVID-19 collection site. Collection is being treated as an urgent care doctor's visit and clients must bring a photo ID and insurance card. The collection facility has a tent outside and have requested that visitors wait in their cars for paperwork to be brought to them by a staff member.
  - Preforming antibody testing. It is NOT required BUT helpful to bring a copy of test results to show you have previously tested positive for the virus. It is \$255.00 total including the office visit for the antibody testing. Some insurances will cover costs. Individuals can walk-in WITHOUT an appointment but CAN NOT have symptoms.

  - May be a walk in but preferred to call ahead for an appointment time. Must be symptomatic, healthcare worker, healthcare provider or first responder. Must bring ID and insurance card.

  - No out of pocket cost. However, insurance is accepted. If no insurance, will use a Social Security number, a driver's license or state ID.

## Closures/Cancellations

• City of St. Augustine Beach - Beach Blast Off Fireworks event scheduled for New Year's Eve has been cancelled for 2020 out of an abundance of caution and in consideration of the safety and welfare of the City's residents, visitors, employees, and volunteers.

## Community Reopening

- Florida Governor Ron DeSantis issued:
  - Executive Order 20-246 assists the transition to Phase 3 by providing local government bodies with an additional one-month period to conduct their meetings virtually.
  - Executive Order 20-211 (Mortgage Foreclosure and Eviction Relief) allowed to expire. The Centers for Disease Control and Prevention (CDC) recently enacted a nationwide residential evictions order that provides federal eviction relief to persons who submit a valid Declaration to their landlord regarding their inability to pay rent. Temporary Halt in Residential Evictions To Prevent the Further Spread of COVID-19
- St. Johns County Board of County Commissioners issued Emergency Order 2020-10
  - Emergency Order adopting requirements of Chapter 29-109 of the Florida Administrative Code for the purpose of allowing remote participation in public meetings by members of the public.
- Florida Governor Ron DeSantis issued <u>Executive Order 20-244</u> and transitioned the State to Phase 3 of the COVID-19 reopening process. Effective upon issuance, the new Executive Order:
  - o Removes state-level restrictions on businesses, such as restaurants.
  - Provides that no COVID-19 emergency ordinance may prevent an individual from working or operating a business.
  - Provides that restaurants may not be limited by a COVID-19 emergency order by any local government to less than 50% of their indoor capacity.
  - States that, if a restaurant is limited to less than 100% of its indoor capacity, such COVID-19 emergency order must satisfy the following:
    - Quantify the economic impact of each limitation or requirements on those restaurants
    - Explain why each limitation or requirement is necessary for public health.
  - Suspends all outstanding fines and penalties, and the collection of such moving forward, applied against individuals related to COVID-19.
  - Executive Order 20-244 supersedes and eliminates all restrictions of Executive Orders 20-112, 20-123 and 20-139, 20-192, 20-214, and 20-223, except as modified per the State.

## Community Information

#### • St. Johns County/Community

- o St. Johns County Mandates the Use of Face Coverings in all County Facilities
  - In an effort to minimize the spread of COVID-19, a face covering mandate for all St. Johns County-owned facilities is in effect. All employees and any person working, doing business, or visiting a County facility are required to wear a face covering when social distancing of six feet or more cannot be maintained. For a full list of exemptions and enforcement policies, please visit www.sjcfl.us. This Emergency Order will remain in effect through the duration of the St. Johns County Emergency Proclamation 2020-1, unless otherwise rescinded by the County Administrator or his designee.
- City of St. Augustine Beach Pursuant to Resolution 20-14, the following regulations are effective on July 7, 2020 at 12:01 AM and shall remain in effect in the City of St. Augustine Beach for so long as a state of emergency is in effect or unless otherwise modified or repealed.

Every person working, living, visiting, or doing business in the City of St. Augustine Beach shall wear a face covering in any indoor location, other than their home or residence, when not maintaining social distancing from other person(s), excluding family members or companions.

- The St. Johns Board of County Commissioners strongly encourages local businesses to mandate that employees and customers wear masks while inside their establishments in order to further prevent the spread of COVID-19.
  - The recommendation is made in conjunction with Pledge St. Johns County, a program that offers businesses the opportunity to pledge to adhere to CDC guidelines regarding cleaning and disinfecting protocols, group size limitations, social distancing recommendations, and enhanced employee protocols and training. Businesses that take the Pledge are eligible to receive a limited mask allotment for distribution to their customers and employees. Business owners or managers who would like to take the Pledge, or patrons who would like to support "Pledge St. Johns County" businesses, may do so by visiting www.pledgesjc.com. - St. Johns County CARES Program
   The St. Johns County Board of County Commissioners has launched St. Johns County CARES, a program to help residents and nonprofit organizations respond to and recover from the economic impact of COVID-19.
  - St. Johns County CARES provides grants to eligible applicants who suffered loss of revenue or income, or incurred unexpected expenses due to the COVID-19 pandemic. Residential households may qualify for up to \$5,000 in grant funding. #### • State of Florida

- If a Floridian's employment has been negatively impacted as a result of the mitigation efforts in Florida to stop the spread of COVID-19, they may be eligible to receive Reemployment Assistance. <u>Reemployment Assistance Service Center</u>
  - Federal Lost Wages Assistance (LWA) program benefits to eligible Floridians.
     This program provides additional benefits for individuals who are eligible for Reemployment Assistance for weeks of unemployment ending on or after Aug. 1, 2020.

The LWA program will provide an additional \$300 per week to eligible Reemployment Assistance claimants. To be eligible for this benefit, claimants must have a weekly benefit amount of at least \$100 in an approved Reemployment Assistance program and must certify that they are unemployed or partially unemployed due to the disruptions caused by COVID-19.

DEO highly recommends that Reemployment Assistance claimants select direct deposit as their means of receiving benefits to ensure payments are received as quickly as possible.
