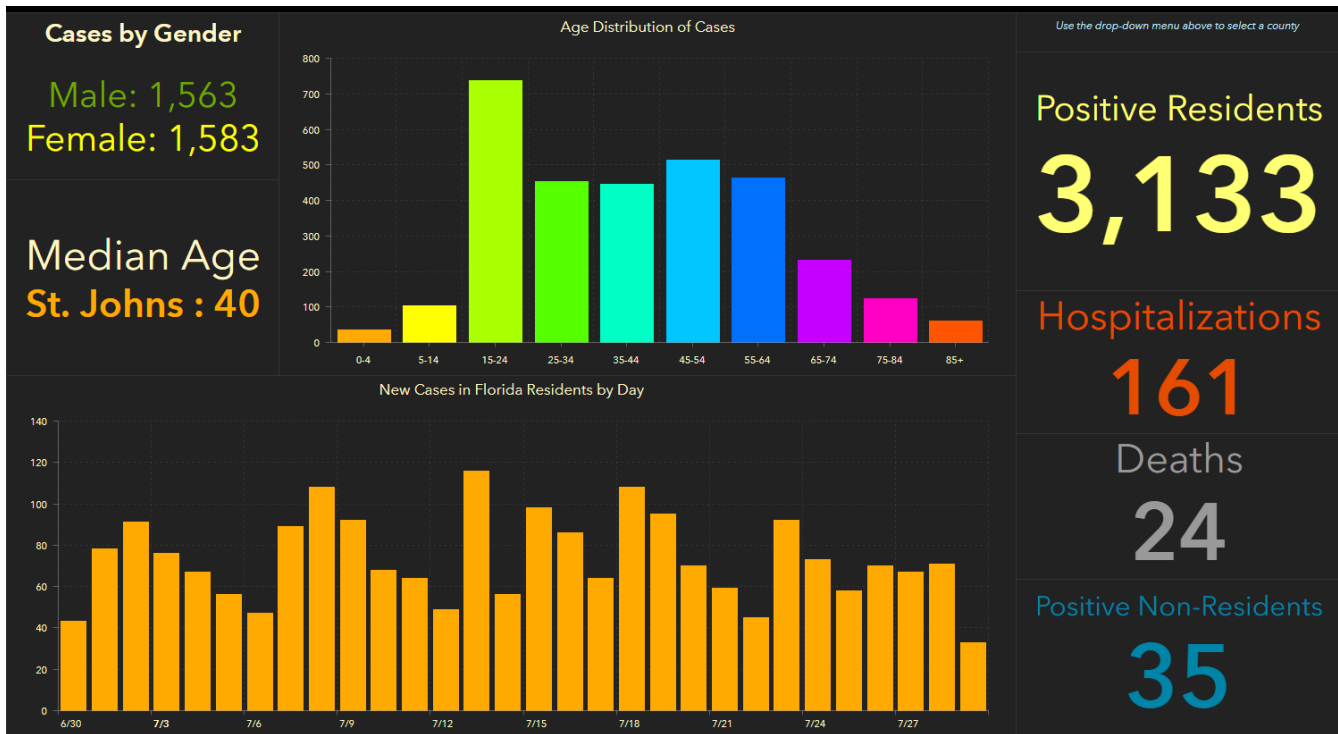

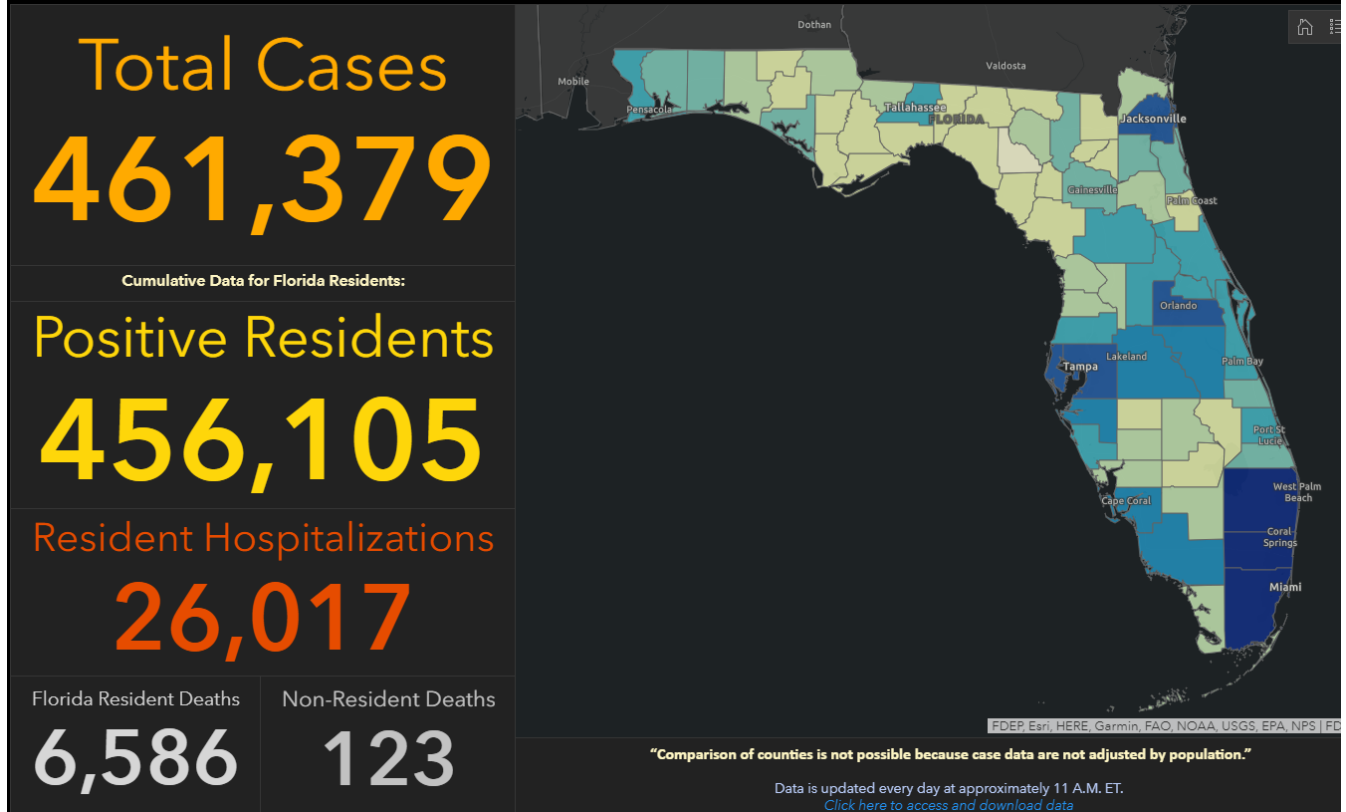

COVID-19 Test Collection Sites

- COVID-19 Test Collection Site at Regency Square Mall – SEARS, 9501 Arlington Expressway, Jacksonville, FL 32225
 - Open to St. Johns County residents and anyone that would like to be tested.
 - Must have Identification
 - This site will operate from 9 a.m. to 5 p.m. seven days a week, for as long as supplies last. While a doctor's order and appointment are not required at this location, clients will be evaluated by a medical professional on site.
- Coronavirus Test Collection Sites in St. Johns County are as follows:
 - Flagler Health+, 400 Health Park Blvd, St. Augustine, FL 32086 Parking Lot B
 - The Testing Site will be open from 7:00 – 11:00 a.m., or until the maximum number of daily tests are collected, Monday - Friday.
 - Testing is available for all ages, and patients do not need to exhibit symptoms, possess a doctor's note, or make an appointment. A parent or guardian must be present for children under 18 to be tested.
 - While insurance cards are not needed, a photo ID is required.
 - Testing is available at no charge

- Florida Department of Health in St. Johns County (DOH-SJC) –St. Johns County Health & Human Services Building , 200 San Sebastian View, St. Augustine, FL 32084. (904) 209-3250
 - As part of disease control investigations, DOH-SJC is collecting specimens for COVID-19 laboratory testing. As part of disease investigations, specimen collection is by appointment-only for those individuals who meet the CDC criteria for testing. For more information about COVID-19 and testing, the Florida Department of Health in St. Johns County’s COVID-19 Call Center is open seven days a week from 8:00 a.m. to 6:00 p.m. and can be reached at 904-209-3250. Calls received outside of standard business hours will be redirected to a DOH-SJC Public Health Nurse.

 - Open to the public from 8:00 a.m. – 8:00 p.m., Monday through Friday, and from 8:00 a.m. to 5:00 p.m., Saturday and Sunday, as a COVID-19 collection site. Collection is being treated as an urgent care doctor’s visit and clients must bring a photo ID and insurance card. The collection facility has a tent outside and have requested that visitors wait in their cars for paperwork to be brought to them by a staff member.
 - Performing antibody testing. It is NOT required BUT helpful to bring a copy of test results to show you have previously tested positive for the virus. It is \$255.00 total including the office visit for the antibody testing. Some insurances will cover costs. Individuals can walk-in WITHOUT an appointment but CAN NOT have symptoms.

Community Reopening

- The Florida Department of Health issued an additional Public Health Advisory in response to COVID-19, providing recommendations to protect Floridians and visitors from this virus.

The Public Health Advisory provides the following recommendations:

1. All individuals in Florida should wear masks in any setting where social distancing is not possible, unless certain conditions apply.
2. All individuals over the age of 65 and all individuals of any age with high-risk health conditions should limit personal interactions outside of the home and take all measures to limit the risk of exposure to COVID-19.
3. All individuals should refrain from participation in social or recreational gatherings of more than 50 people. For all gatherings of fewer than 50 people, individuals should practice social distancing by maintaining a distance of at least six feet from each other and wearing a face covering.

Community Information

- **St. Johns County/Community**
 - St. Johns County - Mandates the Use of Face Coverings in all County Facilities
 - In an effort to minimize the spread of COVID-19, a face covering mandate for all St. Johns County-owned facilities will go into effect at 5 p.m. on Monday, July 27. All employees and any person working, doing business, or visiting a County facility are required to wear a face covering when social distancing of six feet or more cannot be maintained. For a full list of exemptions and enforcement policies, please visit www.sjcfl.us. This Emergency Order will remain in effect through the duration of the St. Johns

County Emergency Proclamation 2020-1, unless otherwise rescinded by the County Administrator or his designee.

- City of St. Augustine Beach - Pursuant to Resolution 20-14, the following regulations are effective on July 7, 2020 at 12:01 AM and shall remain in effect in the City of St. Augustine Beach for so long as a state of emergency is in effect or unless otherwise modified or repealed.

Every person working, living, visiting, or doing business in the City of St. Augustine Beach shall wear a face covering in any indoor location, other than their home or residence, when not maintaining social distancing from other person(s), excluding family members or companions.

- The requirement does not apply to any outdoor activity allowed under City, County, or State order, but face coverings should be readily available when coming within six (6) feet of an individual not part of a person's immediate family or cohabitating living unit.
- If a permit is issued for an outdoor event by the City of Saint Augustine Beach greater than or equal to fifty (50) persons, that permit shall require wearing the face coverings as condition of issuance of the permit and those that attend are required to conform to this resolution.
- All businesses are encouraged to require visitors to wear face coverings with exceptions including the following:
 - Persons under the age of five years.
 - Persons observing social distancing in accordance with CDC guidelines.
 - Persons for whom a face covering would cause impairment due to an existing health condition.
 - Persons working in a business or profession who do not have interactions with other persons.
 - Persons working in a business or profession who maintain social distancing from another person.
 - Persons working in a business or profession where use of a face covering would prevent them from performing the duties of the business or profession, especially if the wearing of a face covering may present a health hazard such as excessive heat.
 - Persons exercising, while maintaining social distancing.
 - Persons eating or drinking.
 - Public safety, fire and other life safety and health care personnel, as their personal protective equipment requirements will be governed by their respective agencies.

- City of St. Augustine - Pursuant to Resolution 2020-22 and Administrative Order 2020-11, the following regulations are effective on June 27, 2020, at 12:01 AM and shall remain in effect in the City of St. Augustine for so long as a state of emergency is in effect or unless otherwise modified or repealed:
 1. Every person working, living, visiting, or doing business in the City of St. Augustine shall wear a face covering in any indoor location, other than their home or residence, when not maintaining social distancing from other person(s), excluding family members or companions.

2. Nothing herein shall require or allow a person to wear a face covering so as to conceal the identity of the wearer in violation of Chapter 876, Florida Statutes.
3. All businesses are encouraged to prohibit entry of any person who is not wearing a face covering with the exception of those below listed persons:
 - Persons under the age of two years.
 - Persons observing social distancing in accordance with CDC guidelines.
 - Persons for whom a face covering would cause impairment due to an existing health condition.
 - Persons working in a business or profession who do not have interactions with other persons.
 - Persons working in a business or profession who maintain social distancing from another person.
 - Persons working in a business or profession where use of a face covering would prevent them from performing the duties of the business or profession.
 - Persons exercising, while maintaining social distancing.
 - Persons eating or drinking.
 - Public safety, fire and other life safety and health care personnel, as their personal protective equipment requirements will be governed by their respective agencies.
 - The requirement shall not apply when a person who is hearing impaired needs to see the mouth of someone wearing a face covering in order to communicate.
 - The requirement does not apply to any outdoor activity permitted under City, County, or State order, but face coverings should be readily available when coming within six (6) feet of an individual not part of a person's immediate family or cohabitating living unit.

- The St. Johns Board of County Commissioners strongly encourages local businesses to mandate that employees and customers wear masks while inside their establishments in order to further prevent the spread of COVID-19. The recommendation is made in conjunction with Pledge St. Johns County, a program that offers businesses the opportunity to pledge to adhere to CDC guidelines regarding cleaning and disinfecting protocols, group size limitations, social distancing recommendations, and enhanced employee protocols and training. Businesses that take the Pledge are eligible to receive a limited mask allotment for distribution to their customers and employees. Business owners or managers who would like to take the Pledge, or patrons who would like to support "Pledge St. Johns County" businesses, may do so by visiting www.pledgesjc.com. - "Pledge St. Johns County" program offers businesses the opportunity to commit to CDC guidelines and ensure St. Johns County residents, visitors, and employees are safe and comfortable in their establishments. Created in partnership with the City of St. Augustine, the City of St. Augustine Beach, the St. Johns County Chamber of Commerce, and the St. Augustine, Ponte Vedra & the Beaches Visitors and Convention Bureau, "Pledge St. Johns County" features a pledge in which businesses vow to adhere to guidelines regarding cleaning and disinfecting protocols, group size limitations, social distancing recommendations, and enhanced employee protocols and training. In addition, they pledge to encourage the use of face coverings by staff and customers. Organizations that take the Pledge will receive a toolkit of printable display materials to let employees and customers know they are a "Pledge St. Johns County" business. Pledged businesses will also be recognized on the "Pledge St. Johns County" website directory. Business owners or
