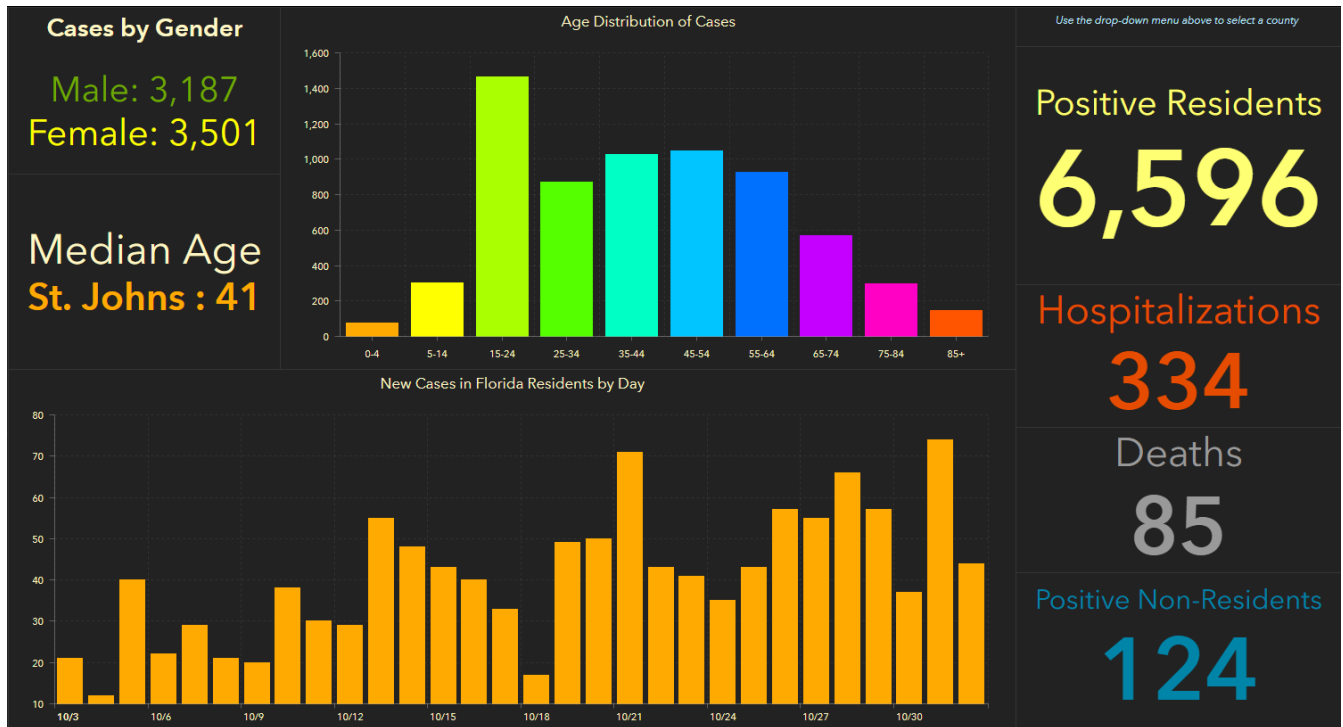

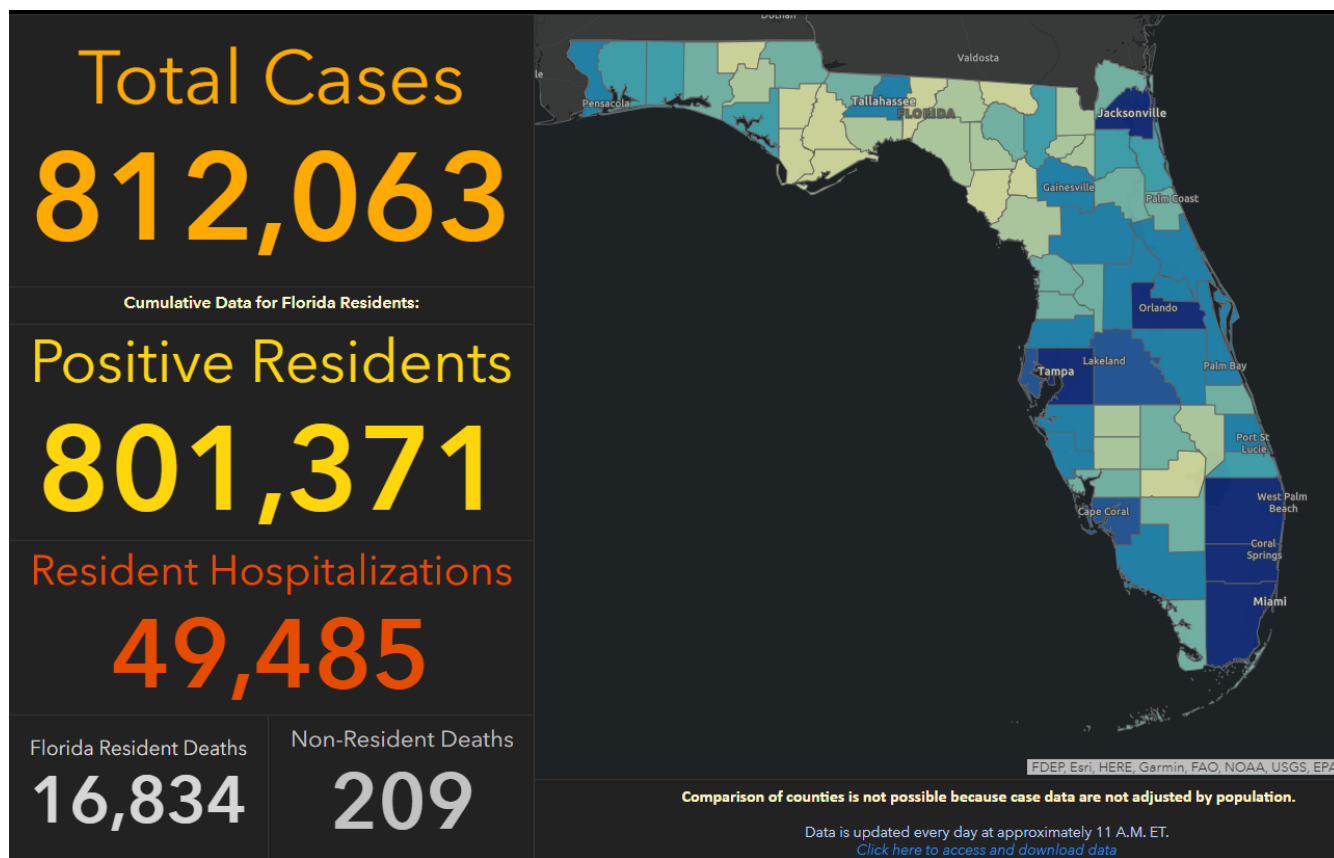
### Current Event Status

## COVID-19 Test Collection Sites

- COVID-19 Test Collection Site at Regency Square Mall – SEARS, 9501 Arlington Expressway, Jacksonville, FL 32225
  - Open to St. Johns County residents and anyone that would like to be tested.
    - Must have Identification
  - This site will operate from 9 a.m. to 5 p.m. seven days a week, for as long as supplies last. While a doctor's order and appointment are not required at this location, clients will be evaluated by a medical professional on site.
- Coronavirus Test Collection Sites in St. Johns County are as follows:
  - Flagler Health+, 400 Health Park Blvd, St. Augustine, FL 32086 Parking Lot B
    - The Testing Site will be open from 7:00 – 11:00 a.m., or until the maximum number of daily tests are collected, Monday, Wednesday, and Friday.
    - Testing is available for all ages, and patients do not need to exhibit symptoms, possess a doctor's note, or make an appointment. A parent or guardian must be present for children under 18 to be tested.
    - While insurance cards are not needed, a photo ID is required.
    - Testing is available at no charge

- Florida Department of Health in St. Johns County (DOH-SJC) –St. Johns County Health & Human Services Building , 200 San Sebastian View, St. Augustine, FL 32084. (904) 209-3250
  - As part of disease control investigations, DOH-SJC is collecting specimens for COVID-19 laboratory testing. As part of disease investigations, specimen collection is by appointment-only for those individuals who meet the CDC criteria for testing. For more information about COVID-19 and testing, the Florida Department of Health in St. Johns County’s COVID-19 Call Center is open seven days a week from 8:00 a.m. to 6:00 p.m. and can be reached at 904-209-3250. Calls received outside of standard business hours will be redirected to a DOH-SJC Public Health Nurse.
- Avencia Medical - Julington Creek Branch, 1633 Race Track Rd, St Johns, FL 32259 (904) 230-6988
  - Open to the public from 8:00 a.m. – 8:00 p.m., Monday through Friday, and from 8:00 a.m. to 5:00 p.m., Saturday and Sunday, as a COVID-19 collection site. Collection is being treated as an urgent care doctor’s visit and clients must bring a photo ID and insurance card. The collection facility has a tent outside and have requested that visitors wait in their cars for paperwork to be brought to them by a staff member.
  - Performing antibody testing. It is NOT required BUT helpful to bring a copy of test results to show you have previously tested positive for the virus. It is \$255.00 total including the office visit for the antibody testing. Some insurances will cover costs. Individuals can walk-in WITHOUT an appointment but CAN NOT have symptoms.

  - CVS Health is conducting drive-up coronavirus testing (COVID-19). Appointments can be made online. Patients must legally reside in the state where the test is given and be 18 years of age or older. Patients being tested are required to stay in their vehicles, no walk-up testing.
  - No out of pocket cost. However, insurance is accepted. If no insurance, will use a Social Security number, a driver's license or state ID.

## Community Information

- **St. Johns County/Community**
  - Florida Department of Health in Saint Johns County phone number has changed to 904-506-6081.
  - St. Johns County - Mandates the Use of Face Coverings in all County Facilities
    - In an effort to minimize the spread of COVID-19, a face covering mandate for all St. Johns County-owned facilities is in effect. All employees and any person working, doing business, or visiting a County facility are required to wear a face covering when social distancing of six feet or more cannot be

This Emergency Order will remain in effect through the duration of the St. Johns County Emergency Proclamation 2020-1, unless otherwise rescinded by the County Administrator or his designee.

- City of St. Augustine Beach - Pursuant to Resolution 20-14, the following regulations remain in effect in the City of St. Augustine Beach for so long as a state of emergency is in effect or unless otherwise modified or repealed.

Every person working, living, visiting, or doing business in the City of St. Augustine Beach shall wear a face covering in any indoor location, other than their home or residence, when not maintaining social distancing from other person(s), excluding family members or companions.

- The St. Johns Board of County Commissioners strongly encourages local businesses to mandate that employees and customers wear masks while inside their establishments in order to further prevent the spread of COVID-19.
  - The recommendation is made in conjunction with Pledge St. Johns County, a program that offers businesses the opportunity to pledge to adhere to CDC guidelines regarding cleaning and disinfecting protocols, group size limitations, social distancing recommendations, and enhanced employee protocols and training. Businesses that take the Pledge are eligible to receive a limited mask allotment for distribution to their customers and employees. - St. Johns County CARES Program

The St. Johns County Board of County Commissioners has launched St. Johns County CARES, a program to help businesses, nonprofit organizations and residents respond to and recover from the economic impact of COVID-19.

  - St. Johns County launched phase II of the St. Johns County CARES Small Business Recovery program. To be eligible, a business must not have received a cumulative total of COVID-19 financial assistance from St. Johns County in 2020 that exceeds \$5,000 for businesses with 0 to 9 employees, \$10,000 for businesses with 10 to 30 employees, \$15,000 for businesses with 31 to 50 employees or \$20,000 for businesses with 51 to 100 employees. - **State of Florida**

- If a Floridian’s employment has been negatively impacted as a result of the mitigation efforts in Florida to stop the spread of COVID-19, they may be eligible to receive Reemployment Assistance. [Reemployment Assistance Service Center](#)
  - Federal Lost Wages Assistance (LWA) program benefits to eligible Floridians. This program provides additional benefits for individuals who are eligible for Reemployment Assistance for weeks of unemployment ending on or after Aug. 1, 2020. The LWA program will provide an additional \$300 per week to eligible Reemployment Assistance claimants. To be eligible for this benefit, claimants must have a weekly benefit amount of at least \$100 in an approved Reemployment Assistance program and must certify that they are unemployed or partially unemployed due to the disruptions caused by COVID-19. DEO highly recommends that Reemployment Assistance claimants select direct deposit as their means of receiving benefits to ensure payments are received as quickly as possible.
