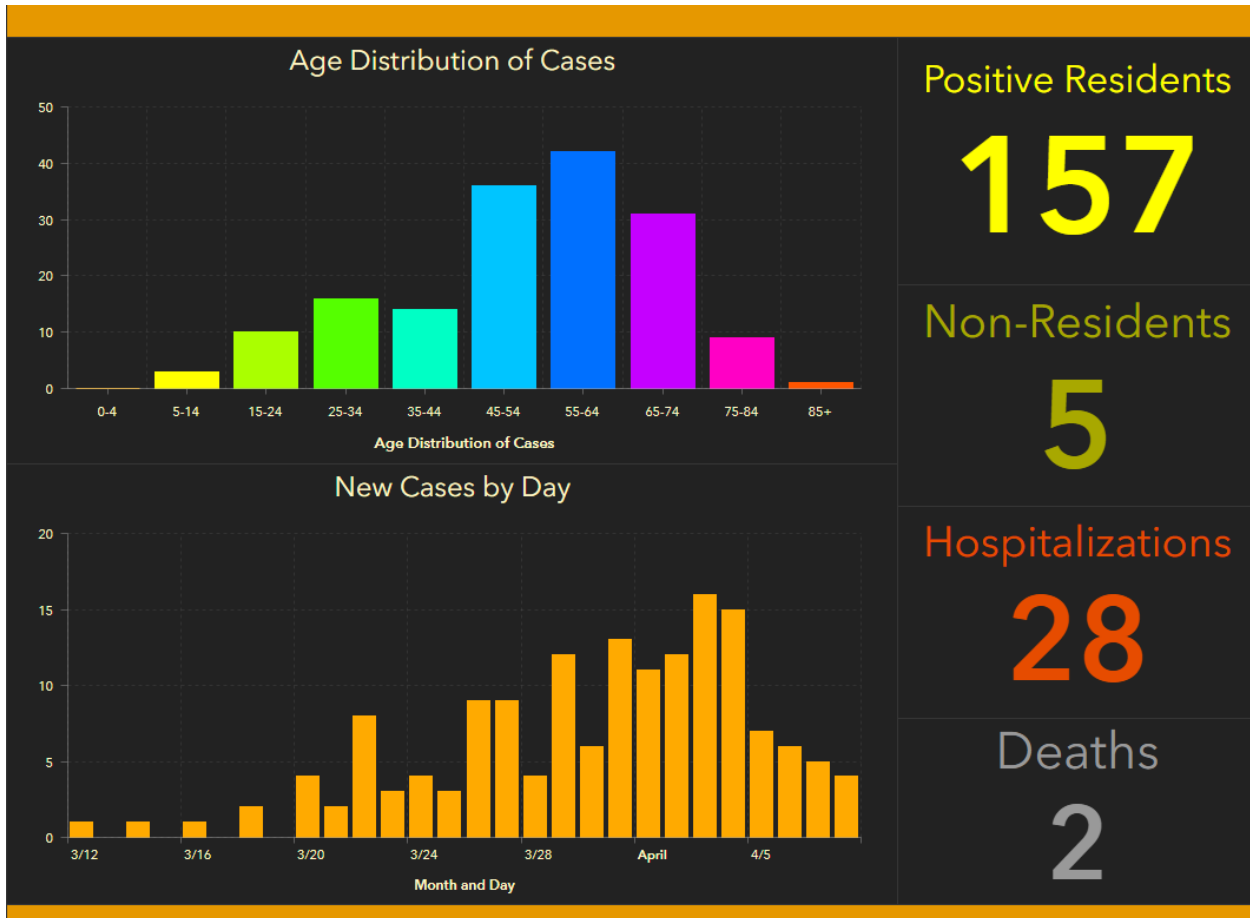

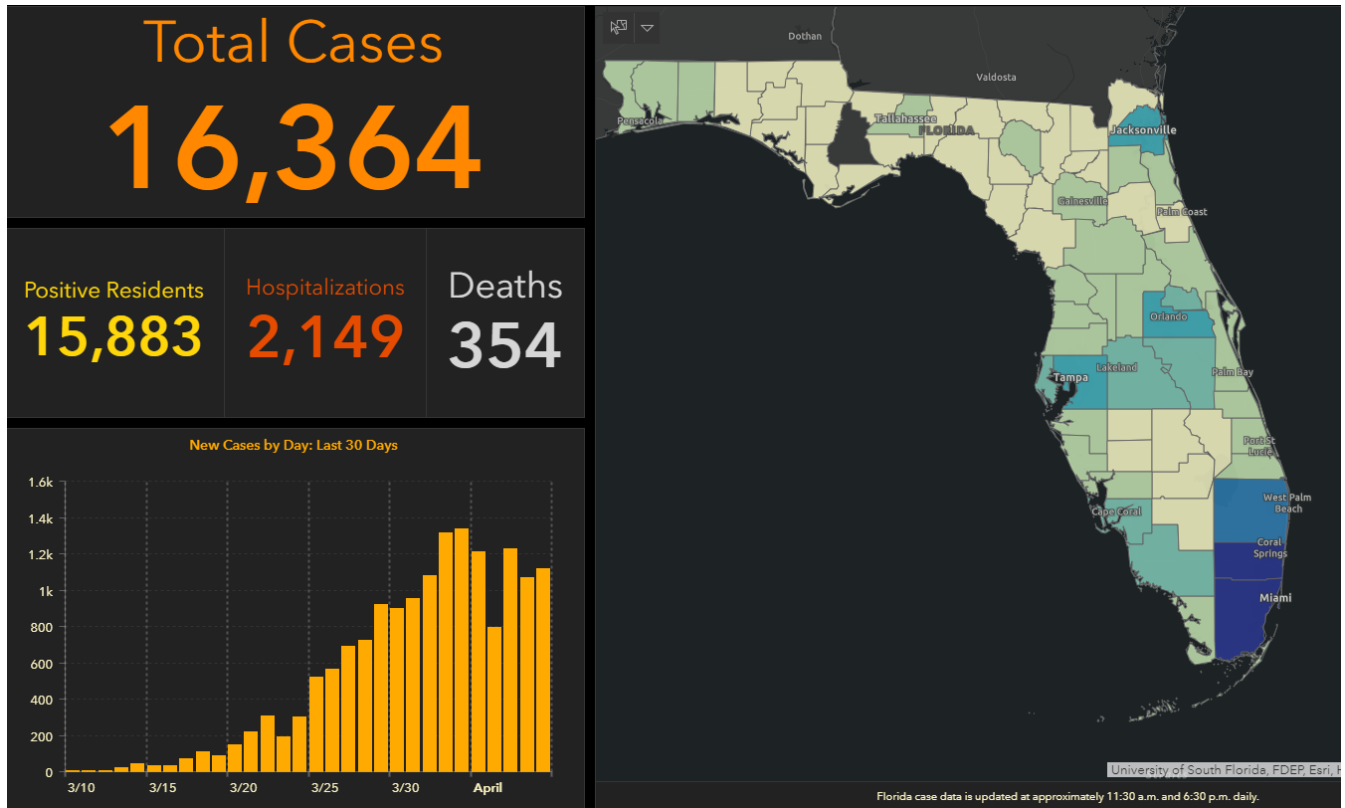
Current Event Status

- The Centers for Disease Control (CDC) is responding to an outbreak of respiratory disease caused by a novel coronavirus (COVID-19) that was first detected in China and has now been detected internationally, including the United States and locally in St. Johns County.

COVID-19 Test Collection Sites

Total Tests in St. Johns County : 2,820

Positive: 162 | Negative: 2,657 | Inconclusive: 2 | Awaiting testing: 24

- Federal Test Collection Site – TIAA Bank Field Lot J (Jacksonville Jaguars Stadium)
 - Open to St. Johns County residents, the federally-sponsored drive-thru COVID-19 testing site at TIAA Bank Field in parking lot J. All ages are accepted, although patients must still meet certain guidelines. These include:
 - On-site temperature of 99.6 or higher.
 - Patient MUST ALSO have respiratory symptoms.
 - First responders and healthcare workers who have direct contact with patients will also be tested, regardless of symptoms. Please bring work ID
 - This site will operate from 9 a.m. to 5 p.m. seven days a week, for as long as supplies last. While a doctor’s order and appointment are not required at this location, clients will be evaluated by a medical professional on site. Patients who do not meet the criteria will not receive a test and will be sent home. Those attempting to be tested should:
 - Bring their own pen.

- Photo Identification.
 - Refrain from taking any fever-reducing medicine four to six hours before testing.
 - Remain inside of vehicle at all times.
- A maximum of four people per car will be screened and tested; each person must be sitting at a functioning window. Additional passengers will be asked to move to the back of the line or return the following day. As long lines are expected, please follow the directions of Jacksonville Sheriff's Office traffic officers. Drivers coming from the west side of town should use Bay Street. Drivers coming from the east side should use Gator Bowl Boulevard. Public restrooms will not be available. American Sign Language and Spanish-language interpreters will be on-site to assist. For questions regarding federal testing sites please call the Toll Free Call Center at 1.877.696.6775.
- Coronavirus Test Collection Sites in St. Johns County are as follows:
 - Flagler Health+ - 400 Healthpark Blvd., St. Augustine, FL 32086. Outdoors at tent
 - Flagler Health+ has established an outdoor test collection site for patients who have a physician order for COVID-19 testing and have pre-registered through the system. The drive through process takes about three minutes. Test results are taking at least 4-5 days on average. Tests results are communicated back to the patient's primary care doctor who notifies the patient of the results. Positive results are also reported to the Department of Health.
 - **Flagler Health+ is also offering a reduced rate of \$25 for people to see a doctor online who may not have a primary care doctor. The online doctor will determine if they need to be tested or not based on their symptoms and an algorithm. The online doctor can also prescribe medications for certain other diagnoses.  - Florida Department of Health in St. Johns County (DOH-SJC) –St. Johns County Health & Human Services Building , 200 San Sebastian View, St. Augustine, FL 32084. (904) 209-3250
 - As part of disease control investigations, DOH-SJC is collecting specimens for COVID-19 laboratory testing. As part of disease investigations, specimen collection is by appointment-only for those individuals who meet the CDC criteria for testing. For more information about COVID-19 and testing, the Florida Department of Health in St. Johns County's COVID-19 Call Center is open seven days a week from 8:00 a.m. to 6:00 p.m. and can be reached at 904-209-3250. Calls received outside of standard business hours will be redirected to a DOH-SJC Public Health Nurse.
 - Avencia Medical - Julington Creek Branch, 1633 Race Track Rd, St Johns, FL 32259 (904) 230-6988
 - Open to the public from 8:00 a.m. – 8:00 p.m., Monday through Friday, and from 8:00 a.m. to 5:00 p.m., Saturday and Sunday, as a COVID-19 collection site. Collection is being treated as an urgent care doctor's visit and clients must bring a photo ID and insurance card. The collection facility has a tent prepared outside and have requested that visitors wait in their cars for paperwork to be brought to them by a staff member. St. Johns County Government	Status:	Operational – St. Johns County facilities are operating under limited public access restrictions.
City of St. Augustine	Status:	Operational – City offices are closed to the Public. Offices will operate and implement numerous methods via the web, email, and phone to assist customers in conducting all necessary business.
City of St. Augustine Beach	Status:	Operational – Public Meeting Rooms closed. Limited public access to City facilities.
St. Johns County School District	Status:	St. Johns County School District (SJCSD) students will continue online/remote learning through May 1, 2020. All school offices will be closed to the public. Access will be limited to phone or email. Please see Community Information regarding Meal Service.
Florida School for Deaf and Blind	Status:	Florida School for Deaf and Blind students will engage in online/remote learning through May 1, 2020.
Flagler College	Status:	All classes will be online for the remainder of the spring semester. All college events through the end of May have also been canceled, including the May Graduation ceremony.
St. Johns River State College	Status:	Classes will be in an online format through the end of the semester. All campuses will remain closed until further notice. All public and College-sponsored events have been canceled for the remainder of the spring semester.
Flagler Hospital	Status:	Operational - All patient visitation has been suspended. Exceptions will be made for the most critical, extenuating circumstances and spouses/partners of Labor and Delivery patients. Permitted visitors will be screened for fever, cough and shortness of breath and will not be allowed entry if they have symptoms. All entry into the hospital will be limited to the Emergency Department entrance.

 - Please place any items that can be picked up curbside instead of bringing it into the landfill.
 - If items cannot be picked up curbside, but it is not a priority to dispose of them, please wait until the "stay at home" requirements have been lifted.
 - If any items must be brought into the transfer station, please be prepared to wait to dump as County staff will be practicing safe social distances. The landfill and the drop-off dumpsters will be limited to three customers at a time.

- The St. Johns County Utility Department is suspending late fees on utility bills, effective immediately, in an attempt to ease financial strain on families and businesses impacted by COVID-19. - **State of Florida**

- Florida residents are encouraged to do their part in helping Florida flatten the curve by anonymously answering questions that range from age and residency, to recent travel, to potential COVID-19 contact. The StrongerThanC-19 community action survey is designed to gather information to help the Department track and slow the spread of COVID-19 in Florida; it is not a symptom checker designed to dispense medical advice. - Governor Ron DeSantis activated the Florida Small Business Emergency Bridge Loan Program to support small businesses impacted by COVID-19. The bridge loan program, managed by the Florida Department of Economic Opportunity (DEO), will provide short-term, interest-free loans to small businesses that experience economic injury from COVID-19. The application period runs through May 8. - Governor DeSantis has ordered a vehicle check on I-95 similar to current operations occurring on I-10 in the panhandle (for vehicles from Louisiana). All southbound traffic will be routed through the weigh station looking for vehicles from New York, New Jersey and Connecticut. Department of Health officials will be asking them questions about their destination and giving them self-quarantine information. They will close the southbound exit to US 17, which may impact the I-95 exit to SR-200. This will be a 24-hour operation.
