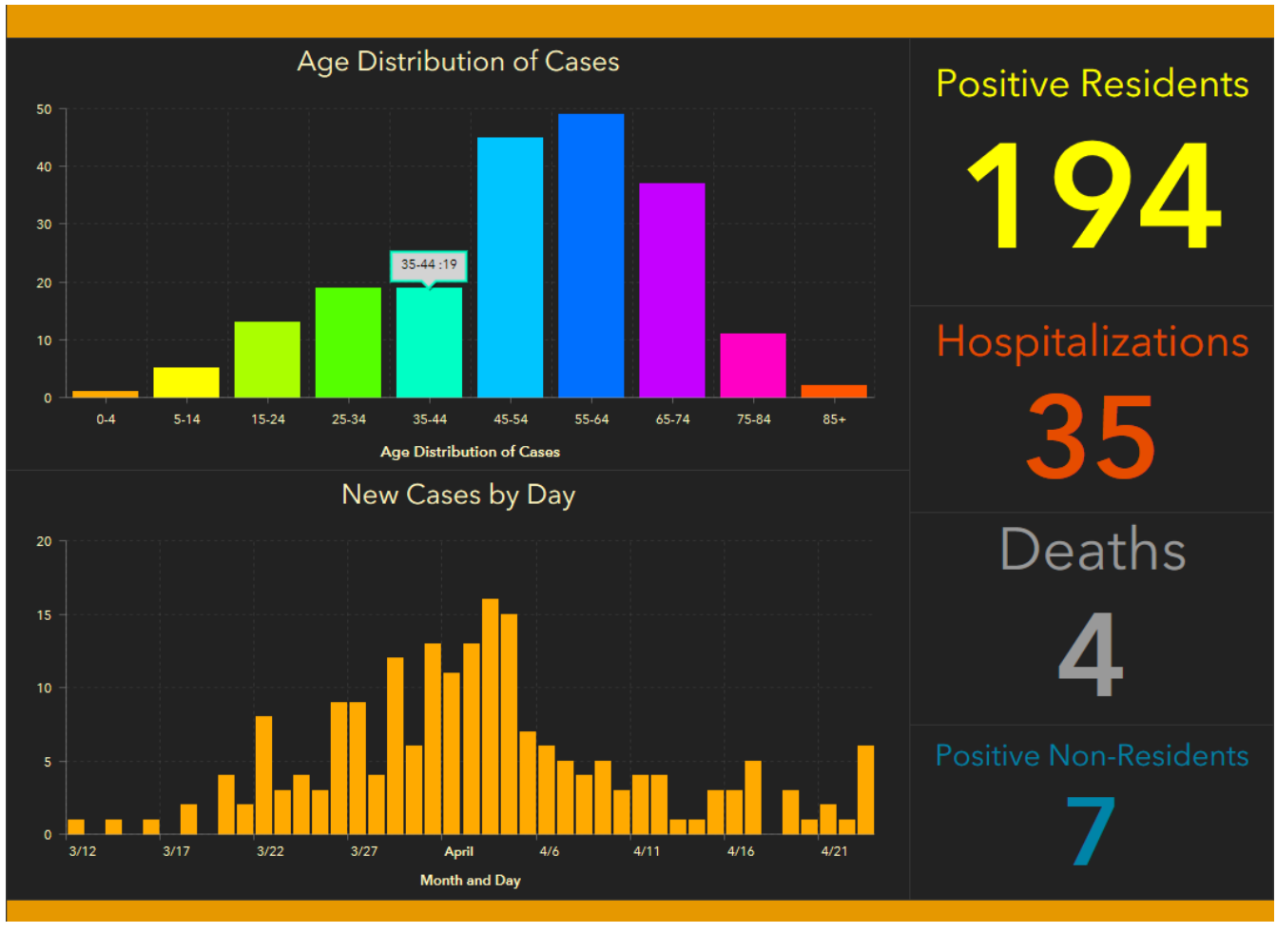

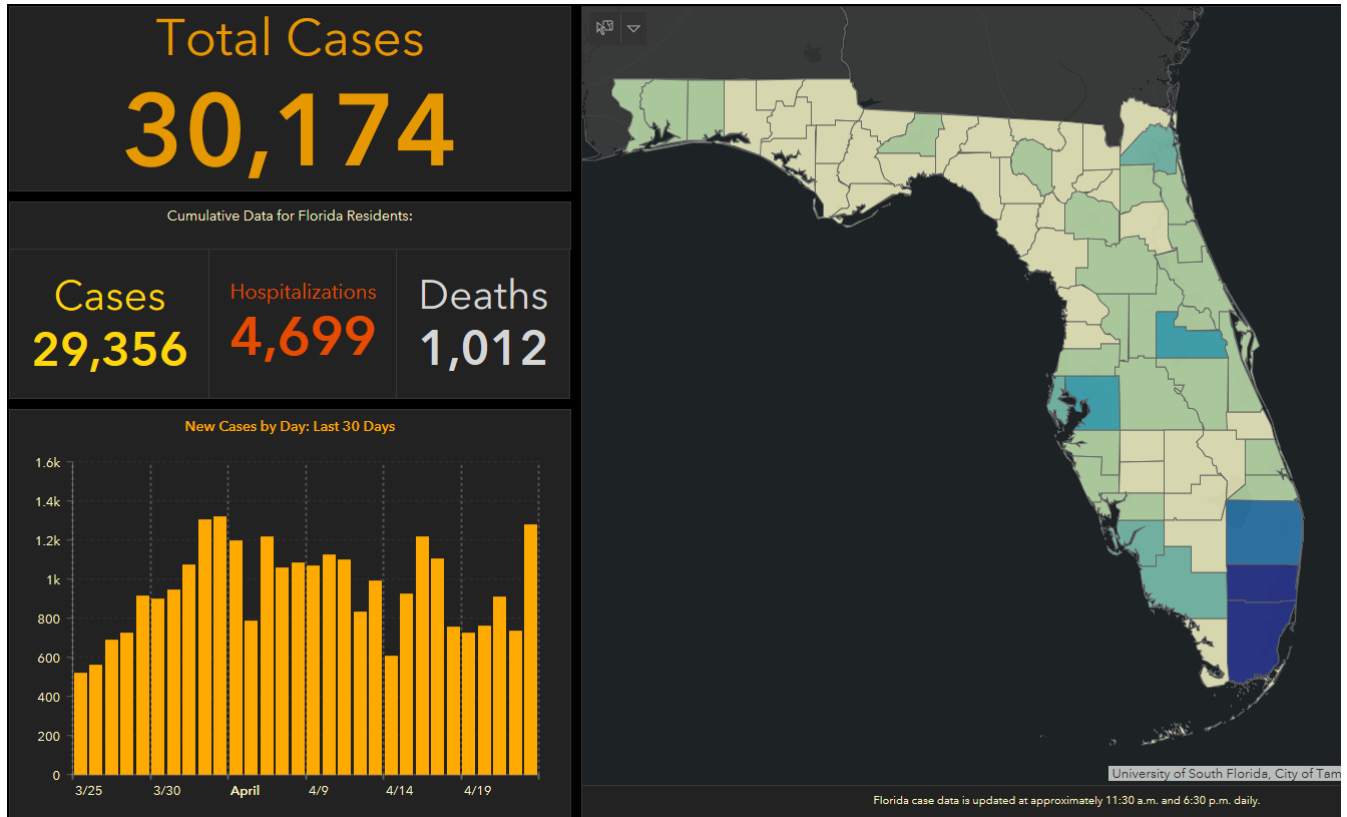
Current Event Status

- The Centers for Disease Control (CDC) is responding to an outbreak of respiratory disease caused by a novel coronavirus (COVID-19) that was first detected in China and has now been detected internationally, including the United States and locally in St. Johns County.

COVID-19 Test Collection Sites

Total Tests in St. Johns County : 4,394

Positive: 201 | Negative: 4,180 | Inconclusive: 1 | Pending: 12

- COVID-19 Test Collection Site at TIAA Bank Field Lot J (Jacksonville Jaguars Stadium)
 - Open to St. Johns County residents, all ages are accepted, although individuals must still meet certain guidelines. These include:
 - Respiratory symptoms.
 - Have an underlying health condition
 - Have come into contact with a confirmed COVID-19 patient
 - First responders and healthcare workers
 - This site will operate from 9 a.m. to 5 p.m. seven days a week, for as long as supplies last and weather permitting. While a doctor's order and appointment are not required at this location, clients will be evaluated by a medical professional on site.
- Coronavirus Test Collection Sites in St. Johns County are as follows:
 - Flagler Health+ - 400 Healthpark Blvd., St. Augustine, FL 32086. Outdoors at tent
 - Flagler Health+ has established an outdoor test collection site for patients who have a physician order for COVID-19 testing and have pre-registered

through the system. The drive through process takes about three minutes. Test results are taking at least 4-5 days on average. Tests results are communicated back to the patient's primary care doctor who notifies the patient of the results. Positive results are also reported to the Department of Health.

- Flagler Health+ is also offering a reduced rate of \$25 for people to see a doctor online who may not have a primary care doctor. The online doctor will determine if they need to be tested or not based on their symptoms and an algorithm. The online doctor can also prescribe medications for certain other diagnoses.  - As part of disease control investigations, DOH-SJC is collecting specimens for COVID-19 laboratory testing. As part of disease investigations, specimen collection is by appointment-only for those individuals who meet the CDC criteria for testing. For more information about COVID-19 and testing, the Florida Department of Health in St. Johns County's COVID-19 Call Center is open seven days a week from 8:00 a.m. to 6:00 p.m. and can be reached at 904-209-3250. Calls received outside of standard business hours will be redirected to a DOH-SJC Public Health Nurse.

 - Open to the public from 8:00 a.m. – 8:00 p.m., Monday through Friday, and from 8:00 a.m. to 5:00 p.m., Saturday and Sunday, as a COVID-19 collection site. Collection is being treated as an urgent care doctor's visit and clients must bring a photo ID and insurance card. The collection facility has a tent prepared outside and have requested that visitors wait in their cars for paperwork to be brought to them by a staff member.  - Open to the public from 9:00 a.m. to 7:00 p.m., Monday through Friday, and from 9 a.m. to 5 p.m., Saturday and Sunday, as a COVID-19 collection site. Collection may be billed as a doctor's visit and/or lab test. The collection facility has signage and has requested that visitors follow the signs as instructed for parking. - St. Johns County EOC is activated to a Level II – Partial Activation.

Government / Schools / Hospital Status

St. Johns County Government	Status:	Operational – St. Johns County facilities are operating under limited public access restrictions.
City of St. Augustine	Status:	Operational – City offices are closed to the Public. Offices will operate and implement numerous methods via the web, email, and phone to assist customers in conducting all necessary business.
City of St. Augustine Beach	Status:	Operational – Public Meeting Rooms closed. Limited public access to City facilities.
St. Johns County School District	Status:	St. Johns County School District (SJCSD) students will continue online/remote learning through the end of the school year. All school offices will be closed to the public. Access will be limited to phone or email.
Florida School for Deaf and Blind	Status:	Florida School for Deaf and Blind students will continue online/remote learning through the end of the school year.
Flagler College	Status:	All classes will be online for the remainder of the spring semester. All college events through the end of May have also been canceled, including the May Graduation ceremony.
St. Johns River State College	Status:	Classes will be in an online format through the end of the semester. All campuses will remain closed. All events have been canceled for the remainder of the spring semester.
Flagler Hospital	Status:	Operational - All patient visitation has been suspended. Exceptions will be made for the most critical, extenuating circumstances and spouses/partners of Labor and Delivery patients. Permitted visitors will be screened for fever, cough and shortness of breath and will not be allowed entry if they have symptoms. All entry into the hospital will be limited to the Emergency Department entrance.

Community Cancellations and Closures

- **St. Johns County Council on Aging (COA) has extended program closures through May 31, 2020. All COA senior centers in St. Johns County (Coastal Community Center, River**

House, Hastings, Trout Creek and THE PLAYERS Community Senior Center in Ponte Vedra), all Integrative Memory Enhancement Program (IMEP) classes, and the Sunshine Center adult day care facility will remain closed through May 31st.

- Meals on Wheels will continue to be delivered, and COA caseworkers and staff will continue to be available by phone and via email. Seniors and caregivers in need of COA's assistance are encouraged to contact COA at 904-209-3700 Monday through Friday from 8 am to 5 pm, via email at info@coasjc.org, and via their website at www.coasjc.org.
- Sunshine Bus service and Paratransit buses will continue to operate at the current levels of service with additional safety measures recommended by the CDC in place to help prevent the spread of COVID-19. For those Sunshine Bus riders requiring essential rides to work, medical appointments, pharmacies and grocery stores, Sunshine Bus will continue to provide trips to essential destinations only. Paratransit riders who require transportation in order to obtain or provide essential services or conduct essential activities may register for Paratransit door-to-door services.  - Please place any items that can be picked up curbside instead of bringing it into the landfill.
 - If items cannot be picked up curbside, but it is not a priority to dispose of them, please wait until the “stay at home” requirements have been lifted.
 - If any items must be brought into the transfer station, please be prepared to wait to dump as County staff will be practicing safe social distances. The landfill and the drop-off dumpsters will be limited to three customers at a time.

- **State of Florida**

- Governor DeSantis has ordered a vehicle check on I-95 similar to current operations occurring on I-10 in the panhandle (for vehicles from Louisiana). All southbound traffic will be routed through the weigh station looking for vehicles from New York, New Jersey and Connecticut. Department of Health officials will be asking them questions about their destination and giving them self-quarantine information. They will close the southbound exit to US 17, which may impact the I-95 exit to SR-200. This will be a 24-hour operation.
