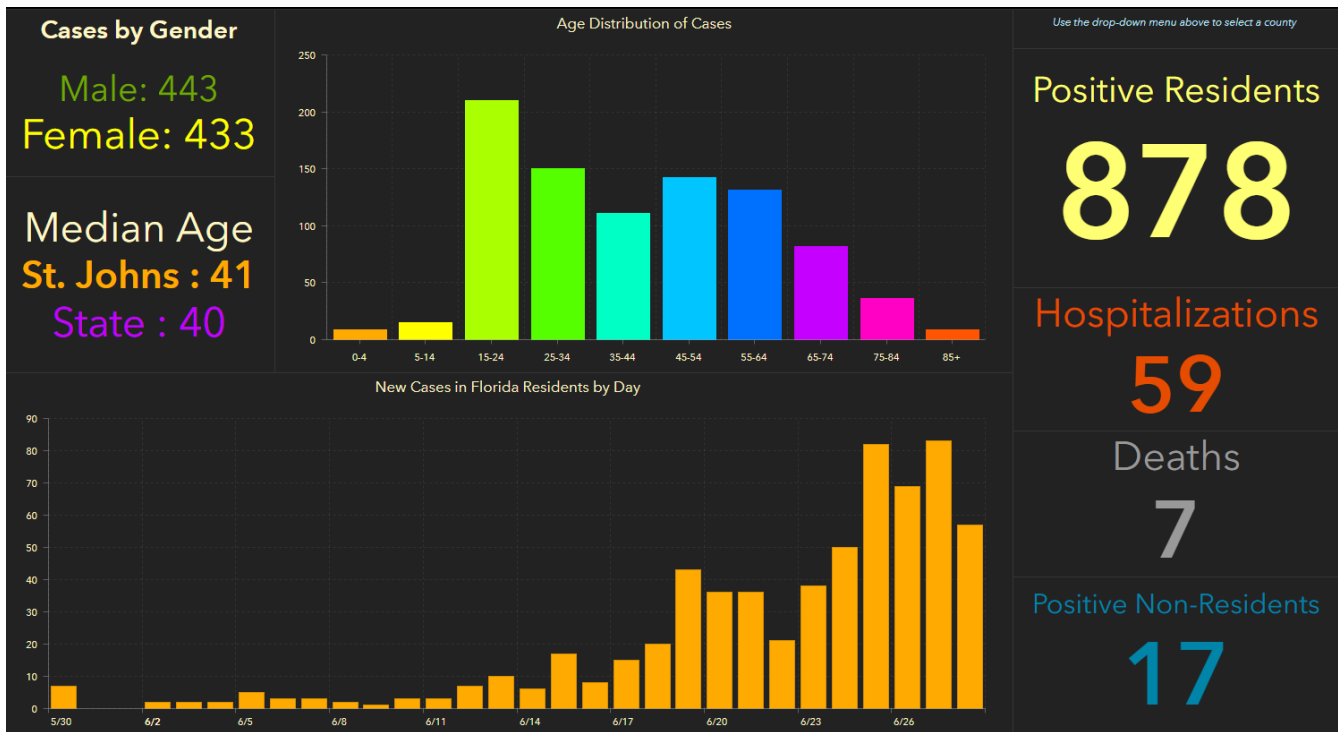

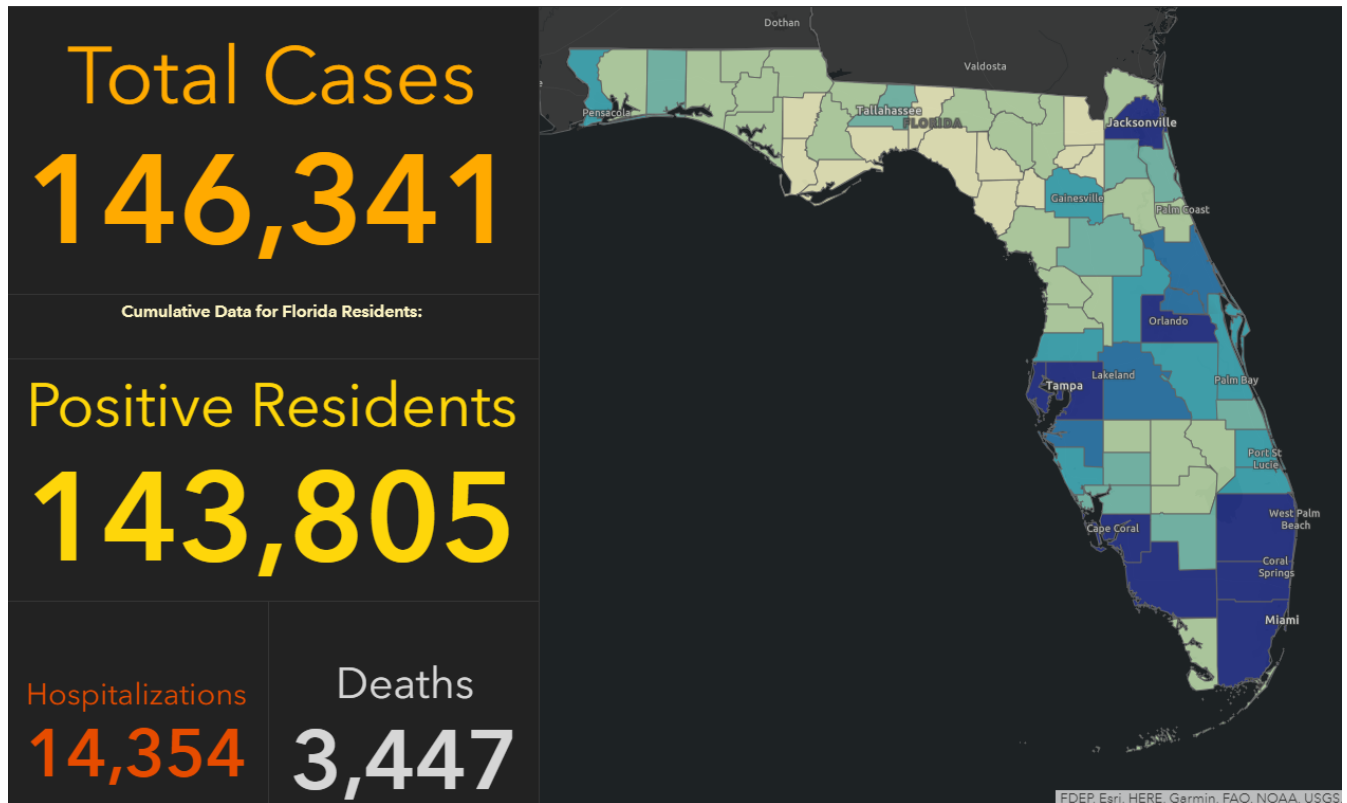

### COVID-19 Test Collection Sites

- COVID-19 Test Collection Site at TIAA Bank Field Lot J (Jacksonville Jaguars Stadium)
  - Open to St. Johns County residents and anyone that would like to be tested.
    - Must have Identification
  - This site will operate from 9 a.m. to 5 p.m. seven days a week, for as long as supplies last and weather permitting. While a doctor's order and appointment are not required at this location, clients will be evaluated by a medical professional on site.

  - As part of disease control investigations, DOH-SJC is collecting specimens for COVID-19 laboratory testing. As part of disease investigations, specimen collection is by appointment-only for those individuals who meet the CDC criteria for testing. For more information about COVID-19 and testing, the Florida Department of Health in St. Johns County’s COVID-19 Call Center is open seven days a week from 8:00 a.m. to 6:00 p.m. and can be reached at 904-209-3250. Calls received outside of standard business hours will be redirected to a DOH-SJC Public Health Nurse.

Collection is being treated as an urgent care doctor’s visit and clients must bring a photo ID and insurance card. The collection facility has a tent outside and have requested that visitors wait in their cars for paperwork to be brought to them by a staff member.
  - Performing antibody testing. It is NOT required BUT helpful to bring a copy of test results to show you have previously tested positive for the virus. It is \$255.00 total including the office visit for the antibody testing. Some insurances will cover costs. Individuals can walk-in WITHOUT an appointment but CAN NOT have symptoms.

## Closures/Cancellations

- State of Florida Restricts On-Premises Alcohol Consumption, Effective June 26, 2020
  - Per the State of Florida's Emergency Order 2020-09, issued on Friday, June 26, all vendors licensed to sell alcoholic beverages for consumption on the premises, and who derive more than 50 percent of gross revenue from the sale of alcoholic beverages, shall suspend the sale of all alcoholic beverages for consumption on the premises, effective immediately. Vendors may continue to sell alcoholic beverages

in sealed containers for consumption off the premises. Vendors who are also licensed as public food service establishments or restaurants may continue to operate for on-premises consumption of food and beverages at tables, provided these vendors derive 50 percent or less of gross revenue from the sale of alcoholic beverages for on-premises consumption.

## Community Reopening

- The Sunshine Bus Company will be implementing its next stage – Phase Two (2) – as a cautious approach to provide limited public transportation service during the continued and close monitoring of our COVID-19 pandemic.

Phase Two (2) will begin on Monday, July 6th, 2020, and consist of five (5) limited Sunshine Bus routes for public service that will operate from Monday – Friday each week during this phase:

- Conn-Ex – This new route combines the existing Connector and Express lines into one route. The new route will begin further in the south by SR-206 and travel as far north as Palencia before heading back south again. The new schedule will be available on the Sunshine Bus website at <https://sunshinebus.net/covid-schedules/>
- Circulator – This route will run its normal schedule.
- Green – This route will run its normal schedule.
- Orange – This route will run its normal schedule.
- Teal – This route will run its normal schedule.

During Phase 2, all passengers will be required to wear a mask. If passengers do not already own a mask, they can purchase one from the Driver(s) for \$1.00.

- The Florida Department of Health issued an additional Public Health Advisory in response to COVID-19, providing recommendations to protect Floridians and visitors from this virus.

The Public Health Advisory provides the following recommendations:

1. All individuals in Florida should wear masks in any setting where social distancing is not possible, unless certain conditions apply.
2. All individuals over the age of 65 and all individuals of any age with high-risk health conditions should limit personal interactions outside of the home and take all measures to limit the risk of exposure to COVID-19.
3. All individuals should refrain from participation in social or recreational gatherings of more than 50 people. For all gatherings of fewer than 50 people, individuals should practice social distancing by maintaining a distance of at least six feet from each other and wearing a face covering.

St. Johns County is currently in Phase 2, which dictates:

- Restaurants, bars, and other vendors licensed to sell alcoholic beverages, excluding nightclubs, may operate at fifty percent of the establishment's indoor capacity and at full capacity outside with appropriate social distancing. Bar areas may operate with seated service.
- Entertainment businesses, including but not limited to movie theaters, concert houses, auditoriums, playhouses, bowling alleys and arcades may operate at fifty

percent of the establishment's capacity with appropriate social distancing between groups and proper sanitization protocols.

- In-store retail businesses, gyms, and fitness centers may operate at full capacity with appropriate social distancing measures and proper sanitization protocols.
- Personal services including but not limited to barber shops, hair salons, nail salons, tattooing, body piercing, tanning, and massage may operate while adhering to appropriate safety guidelines outlined by the Florida Department of Health.

## Community Information

- **St. Johns County/Community**

- Pursuant to Resolution 2020-22 and Administrative Order 2020-11, the following regulations are effective on June 27, 2020, at 12:01 AM and shall remain in effect in the City of St. Augustine for so long as a state of emergency is in effect or unless otherwise modified or repealed:
  1. Every person working, living, visiting, or doing business in the City of St. Augustine shall wear a face covering in any indoor location, other than their home or residence, when not maintaining social distancing from other person(s), excluding family members or companions.
  2. Nothing herein shall require or allow a person to wear a face covering so as to conceal the identity of the wearer in violation of Chapter 876, Florida Statutes.
  3. All businesses are encouraged to prohibit entry of any person who is not wearing a face covering with the exception of those below listed persons:
    - Persons under the age of two years.
    - Persons observing social distancing in accordance with CDC guidelines.
    - Persons for whom a face covering would cause impairment due to an existing health condition.
    - Persons working in a business or profession who do not have interactions with other persons.
    - Persons working in a business or profession who maintain social distancing from another person.
    - Persons working in a business or profession where use of a face covering would prevent them from performing the duties of the business or profession.
    - Persons exercising, while maintaining social distancing.
    - Persons eating or drinking.
    - Public safety, fire and other life safety and health care personnel, as their personal protective equipment requirements will be governed by their respective agencies.

- The requirement shall not apply when a person who is hearing impaired needs to see the mouth of someone wearing a face covering in order to communicate.
  - The requirement does not apply to any outdoor activity permitted under City, County, or State order, but face coverings should be readily available when coming within six (6) feet of an individual not part of a person's immediate family or cohabitating living unit.
- The St. Johns County Board of County Commissioners will hold a special meeting beginning at 8:30 a.m. on Tuesday, June 30, 2020, in the Auditorium located in the County Administration Building. The meeting agenda can be found at <https://stjohnsclerk.com/records/board-records/agendas/>. Under the St. Johns County Emergency Proclamation 2020-03, St. Johns County Boards and Committees that meet during the COVID-19 health emergency may do so remotely and without a physical quorum of the members present. Members of the community who would like to participate in public comment during the meetings may do so by calling 904.209.1265. - The St. Johns Board of County Commissioners strongly encourages local businesses to mandate that employees and customers wear masks while inside their establishments in order to further prevent the spread of COVID-19. The recommendation is made in conjunction with Pledge St. Johns County, a program that offers businesses the opportunity to pledge to adhere to CDC guidelines regarding cleaning and disinfecting protocols, group size limitations, social distancing recommendations, and enhanced employee protocols and training. Businesses that take the Pledge are eligible to receive a limited mask allotment for distribution to their customers and employees.
