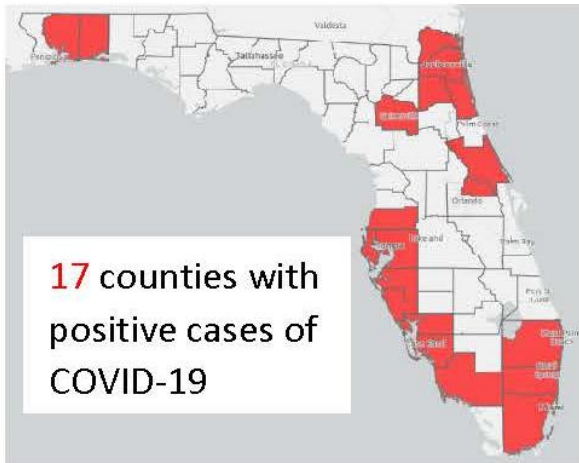

### Current Event Status

- The Centers for Disease Control (CDC) is responding to an outbreak of respiratory disease caused by a novel coronavirus (COVID-19) that was first detected in China and has now been detected internationally, including in the United States.
- Positive Cases of COVID-19 in the State of Florida as of March 13, 2020 at 1:53 pm (most recent official report from FDOH):
  - 45 - Florida Residents
  - 5 - Florida Cases Repatriated\*
  - 6 - Non-Florida resident
  - 2 - Deaths



- Number of Negative Test Results: 478
- Number of Pending Testing Results: 221
- Number of People Under Public Health Monitoring\*\*:
  - 365 – Currently being monitored
  - 1413 – People monitored to date
- \*Florida Cases Repatriated: The United States Department of State officially coordinated the return of a person living in Florida to the United States and those persons are isolated at a federally designated site until healthy. A repatriated case is when the United States Department of State officially coordinates the return of a Florida resident to the United States.
- \*\*People Under Public Health Monitoring: The number of people under public health monitoring includes those at risk of having been exposed to COVID-19 who are monitoring their health under the supervision of public health officials.
- St. Johns County - 63-year old male New York resident who is currently in St. Johns County has tested positive. He is isolated and will continue to remain isolated until cleared by public health officials. This is a travel-related case.

### Current and Anticipated Actions/Protective Measures

- We are coordinating with our community partners in an effort to keep our community prepared and safe.
  - Participating in daily statewide conference calls with Florida Division of Emergency Management (FDEM)
- The Governor’s Office issued Executive Order 20-51 directing the State Health Officer and Surgeon General to declare a public health emergency in the State of Florida. - The State Surgeon General issued a Declaration of Public Health Emergency on March 1, 2020.

- Florida Division of Emergency Management issued Emergency Orders 20-001 and 20-002, establishing purchasing guidelines and healthcare facility guidelines.

## Community Cancellations and Closures

- The Players Championship has been cancelled.
- All public events scheduled March 14<sup>th</sup> through April 1<sup>st</sup> at the St. Augustine Amphitheatre and Ponte Vedra Concert Hall will be cancelled or postponed.
- Beginning Monday, March 16<sup>th</sup> Council on Aging (COA) Senior Centers, will be closed through April 7, 2020. Meals on Wheels service will continue.
- City of St. Augustine, out of an abundance of caution has cancelled the following events:
  - St. Augustine Celtic Music & Heritage Festival and Parade
  - Lions Seafood Festival
  - Rotary's Rhythm and Ribs Festival
  - Additionally, the free park & ride spring shuttle services currently scheduled through April 1, 2020, have been cancelled.
- St. Johns County School District: out-of-state field studies, interscholastic activities, sporting events and school district work-related travel have been cancelled.
