

## St. Johns County Community Development Block Grant (CDBG) Proposed Substantial Amendment to the 2021-2022 Annual Action Plan

**Notice to Citizens:** St. Johns County receives Community Development Block Grant (CDBG) funds as an entitlement community. This program is administered through the U.S. Department of Housing and Urban Development (HUD) for the benefit of low/moderate income residents. St. Johns County uses CDBG funds within the unincorporated areas of the County and within the city limits of St. Augustine Beach. The County has prepared a 2021-2025 Consolidated Plan and a 2021-2022 Annual Action Plan as required by HUD to receive CDBG funding. The Consolidated Plan specifies priorities for the CDBG program. The Annual Action Plan establishes activities and projects for how the funds will be used for qualifying purposes. St. Johns County is now considering a Substantial Amendment to its 2021-2022 Annual Action Plan.

**Consolidated Plan:** The Five Year Consolidated Plan was prepared by St. Johns County and includes a discussion of needs and strategies to meet those needs. It was developed with participation from County staff and elected officials, affordable housing, and social service providers, and local citizens. Various public hearings, meetings, and discussions were held to obtain citizen input on community needs. As a result of this process the following priorities were developed:

**Priority #1– Rehabilitation of Existing Housing-** Focus on improving health and safety, code violations, accessibility and sustainability for extremely low to moderate income individuals (including but not limited to elderly, disabled and veterans) below 50% AMI.

**Priority #2 – Public Services-** Public service provided will enhance the living environment of the targeted population by addressing basic needs that are not being met as well as the economic factors to adequately provide for themselves.

**Priority #3– Public Facilities and Infrastructure-** Provision of adequate infrastructure and public facility to ensure their operation at an efficient level of service and enhance the livability of low and moderate income neighborhoods.

**Priority #4 – Homeless Assistance-** Provide housing and support services to assist individuals and families who are homeless or at risk of becoming homeless.

**Priority #5 – Affordable Housing-** Increase the supply of affordable houses for sale and affordable rental housing available to very- low, low, moderate, and middle-income



residents as well as veterans, elderly, disabled, and homeless persons through new construction or acquisition.

**Priority #6 – Economic Development-** Promotion of Economic Development activities to respond to general needs as well as the impact of COVID-19.

Proposed change to the 2021-2022 Annual Action Plan: The Public Service Project Kids Safe Zone has requested funds to continue to provide free after-school mentoring, tutoring, and homework assistance to low- and moderate- (L/M) income families in the West Augustine Community Redevelopment Area. The program benefits parents who have issues affording quality after-school educational opportunities and care. Therefore, it is proposed to re-allocate \$33,405.25 in funding from the Planning and Administration Activity, which are unused funds, and apply it to the Public Service Project-Kids Safe Zone.

**Public Comment Period:** As required by HUD, the proposed Substantial Amendment to the 2021-2022 Annual Action Plan is available for review Monday – Friday, 8:00 AM – 5:00 PM at the Health and Human Services Department at 200 San Sebastian View, Suite 2300, St. Augustine, FL 32084. A public hearing will be held at 10:00 a.m. on January 25, 2024 in the Kingfisher Conference Room in the Health and Human Services building at 200 San Sebastian View, Augustine, FL 32084. **Public Hearing:** Final action will be taken on the proposed Substantial Amendment to the 2021-2022 Annual Action Plan, at the regularly scheduled meeting of the Board of County Commissioners to be held at 9:00 a.m. on February 6, 2024.
