### **Applicable Land Development Code Standards:**

Section 2.02.05 – Temporary Uses

Section 3.10 – Vilano Beach Town Center Overlay District

**Summary of Request:** The Applicant is requesting design approval to allow for a fishing weigh-in tournament and festival to take place on June 8, 2024, from 12pm to 6pm, at the Vilano Beach Pier. The weigh-in event has been hosted at the Vilano Beach Pier since 2020, and the Applicant states that the event has grown into the largest kingfish tournament in the world. This year, a festival is proposed to be added in conjunction to the tournament. The applicant has partnered with Vilano Beach Main Street to discuss vendor displays, food trucks, and drink sales and has noted that shuttles and portable restrooms will be brought to the site to help accommodate the crowd. The Applicant notes that the event generated funds to allow for community outreach donations to several local groups.

**Project Location**: The subject site is located in Vilano Beach Town Center, to the west side of the Vilano Rd. roundabout, at the fishing pier and pavilion parking area.

**Staff Review—Planning Division:** The proposed event may be allowed as designated by the Design Review Board through a Regular Review per LDC Section 3.10.05.N.

The Applicant has submitted two exhibits for the Design Review Board's consideration—one is specific to the Vilano Rd. roundabout, and the other is specific to the pier. Staff requested additional information from the Applicant, specifically that reference in LDC Section 3.10.05.M.2 (see Applicable Code Sections, below). In response, event partner Vilano Beach Main Street contacted Staff, stating that all vendors will be located on private property, and information/refreshments/musical entertainment will be housed under the pavilion.

A Special Use Permit from the Parks and Recreation Department and/or additional St. Johns County permits will be required prior to any event taking place (ex. St. Johns County Sheriff's office, St. Johns County Public Works).

### **Applicable Code Sections:**

LDC Section 3.10.05.K. – Use of the Public Right-of-Way

- 1. A clear pathway, parallel with the street, with a minimum width of 5 feet shall be provided for the comfortable movement of pedestrians.
- 2. A clear distance with a minimum of five feet (5') shall be provided from any alley, crosswalk, fire hydrant, or similar use.
- 3. The sidewalk area shall be maintained in a neat and orderly manner at all times and the area shall be cleaned of all debris and stains on a periodic basis during the day and again at the closing of each business day, ensuring a tidy appearance.

### <u>LDC Section 3.10.05.M</u> – Public Pavilions & Fishing Pier Vendors

- 1. Vendors may be allowed at the Fishing Pier, Fishing Pier Pavilion & Beach Pavilion as a temporary use with appropriate permits.
- 2. The Design Review Board shall evaluate the initial application for vendors through a Regular Review. The Regular Review application shall include a general site plan depicting the location within the Public Pavilions or Pier, a maximum number of vendors; style, size and dimensions of vendor stalls; signage; and duration of each event consistent with Section 2.02.05.

### LDC Section 3.10.05.N - Outdoor Sales, Market and Special Event Vendors, Other Areas

- 1. Outdoor sales, market, special event vendors, and other temporary uses may be allowed within the Vilano Beach Town Center as designated by the Design Review Board through a Regular Review. The Regular Review may be granted upon a determination that the request will not impose a burden or substantial negative impact, the request is consistent with Section 2.02.05 and the request is consistent with the following minimum standards:
  - a. Outdoor sales adjacent to retail uses may be permitted on sidewalks. The location of outdoor sales shall provide for continuous pedestrian movement.
  - b. Markets, bazaars, and substantially similar activities, which primarily sell arts, crafts, and local food products along with other goods, may be permitted on unimproved property.
  - c. Special event vendors may be distributed throughout the Town Center on improved, unimproved and public areas, such as sidewalks or parking areas for the duration of the registered Special Event (such as sunset celebrations, sport/race events, charitable concerts or similar community events).
  - d. Other Temporary Uses as may be permitted under Section 2.02.05.

### DRB Application Old School Kingfish Shootout June 8, 2024

### **About the Old School Kingfish Shootout:**

2024 is our 5th year hosting the Old School Kingfish Shootout and we are proud to have the Largest Kingfish Tournament in the World! Last year, we had 654 boats with more than 2,600 participants, including more than 350 Junior Anglers and 325 Lady Anglers. We have hosted the weigh-in for our tournament at the Vilano Beach Pier since 2020 and it has worked great. Most participants bring their fish by boat, so there is minimal impact on vehicular traffic.

After record numbers of participants and fish weighed in 2023, we believe that adding a festival, in conjunction with the tournament weigh-in, will help us enhance our event even further. By adding a festival, we can make our event a community event. We have partnered with Vilano Beach Main Street to help us bring this idea to life and they have brought many great ideas and recommendations to the table. We have discussed vendor displays, food trucks, and sale of beer and wine through our partnership with Champion Brands. We are planning to utilize St Augustine Marina's property as the headquarters for our festival. Shuttles and portable restrooms will be brought in to help accommodate the crowd.

We are excited about the new partnership with Vilano Beach Main Street and look forward to learning and making our event bigger and better every year!

### **Closure Requests:**

### Vilano Beach Pier

We are requesting permission to close the Pier on June 8 from 12-6 for the Old School Kingfish Shootout Tournament Weigh-In and Festival. Closure will help ensure safety of tournament participants and attendees. Fishermen on the Pier have leads on their lines which can be a danger when casting. Additionally, closure will allow for more space for vendors to set up displays on the Pier. NOTE: The Boat Tours are an exception to this closure request. No problem for that operation to continue as scheduled. ADDITIONAL NOTE: The tournament will be postponed if the wind is blowing more than 15 MPH.

### 2<sup>nd</sup> Street (Dead End)

### MINUTES OF THE ST. JOHNS COUNTY, FLORIDA DESIGN REVIEW BOARD OF THE NORTH COASTAL OVERLAY DISTRICT

### Wednesday, March 13, 2024 Permit Center Conference Room 1

**Members present:** Linda LaCerva (Chair), Jean Miller, Sacha Martin (Vice-Chair), William Morton, Jane Norton, Mary Sullivan, Kathleen Floryan (arrived 4:14)

**Staff present:** Christine Valliere, Senior Assistant County Attorney; Teresa Bishop, Planning Manager, Growth Management; Amanda Rose, Overlay Planner; Jamie Baccari, Assistant Parks & Recreation Director; Douglas Tarbox, CIP Manager; Christopher Gatchell, Engineering Inspection Supervisor, Nathan Gottschalk, Public Works Project Manager

### Call to Order

- LaCerva called meeting to order at approximately 4:00 PM and read the Public Notice Statement.
- LaCerva called for public comment not on the agenda; there was none.
- Martin stated the Vilano Bridge 5K/10K Run and 1 Mile Fun Run is happening on March 30.
- Bishop introduced Amanda Rose, the county's new Overlay Planner. Rose stated that she is excited to join the team and to work with the board.

Agenda Item: - LaCerva opened NCDRB 2023-06 North Beach Park Improvements.

- Ex-parte Disclosure: None
- Applicant Presentation: Applicant John Grady introduced himself as the civil engineer for the project, and Brian Sawyer introduced himself as the project architect. Grady presented the plans and explained that the project scope includes the improvement of parking, the addition of a restroom/shower/changing area, the introduction of new playground equipment, the installation of a coquina walking trail, and the refacing of educational signage. Grady noted that the previous proposal had been amended to reflect community and DRB feedback re: parking locations and playground equipment. Grady also noted the locations of the dry retention areas and explained the materials to be used for the parking areas. Additional presentation was provided on the proposed bike racks, signage, planting locations, and buildings.
- **Board Discussion**: Various board member questions throughout the presentation centered around the parking count, its location, and its configuration; drainage, showers, bench style and material, and parking. Grady, Sawyer, Baccari, and Tarbox answered these questions.

- Public Comment: Vivian Browning inquired how the proposed trail will tie into that within the upcoming DOT project and the timeline for park construction in relation to other park improvement projects. She also asked if fencing will be utilized to protect children from the roadway traffic. Discussion occurred amongst the LaCerva, Browning, Baccari, and Tarbox. Browning also stated that Vilano Beach gate at the beach access needs to be opened to alleviate parking issues in the Town Center area.
- Additional Board Discussion: Martin commented on the educational signage, art installations, and changing room doors. Floryan commented on the accessible parking location and playground slide types. Additional board discussion security, trash bin locations/screening/service times, playground equipment and shade sails, lighting, and maintenance. Baccari, Tarbox, Sawyer, and Grady addressed the questions.
- **Motion**: LaCerva motioned to approve Application NCDRB 2023-06 North Beach Park Improvements as presented. Miller seconded, and the motion passed 5-0.

### **Minutes**

- January 10, 2024: Floryan motioned to approve; Miller seconded. The motion passed 5-0.
- February 14, 2024: Floryan motioned to approve; LaCerva seconded. The motion passed 5-0.

### **Staff Reports**

• Bishop shared information about the upcoming Comprehensive Plan Update district community meetings from March 26-28. LaCerva encouraged everyone to attend. Bishop shared information about the charrette style engagement tools that will be utilized during these meetings. Bishop and Valliere answered questions about the Strategic Plan update. Rose noted that Comprehensive Plan Update cards are available to use to access the website and pass out to interested citizens.
