

Staffing is critical to the success of an economic development office because it directly influences the county's ability to attract investment, support local businesses, and implement strategic growth initiatives. Strength and level of staffing is paramount to success:

### **Expertise and Specialization**

 Economic development is a multidisciplinary field requiring knowledge of business, finance, urban planning, workforce development, and public policy. Skilled staff bring expertise in these areas, enabling the office to craft competitive incentive programs, analyze market trends, and navigate complex regulations.

### **Relationship Building**

• Staff are the face of the office to site selectors, business leaders, and government agencies. Effective team members build trust and relationships that are essential for long-term partnerships and investment attraction.

### **Responsiveness and Efficiency**

• Economic opportunities often come with tight deadlines. A well-staffed office can quickly respond to proposals, conduct site tours, and process incentive applications without delay, which helps the community stay competitive.

• From managing infrastructure grants to overseeing workforce initiatives, execution is everything. Competent staff ensure that the department's vision is turned into measurable outcomes that benefit the local economy.
