**Public Notice: St. Johns County Community Development Block Grant
Proposed 2025-2026 Annual Action Plan**

The St. Johns County Health and Human Services is developing its PY 2025 Annual Action Plan as required by the US Department of Housing and Urban Development (HUD) to receive Community Development Block Grant (CDBG) funding. St. Johns County receives CDBG funds as an entitlement community to benefit low-to-moderate income residents. St. Johns County may use CDBG funds within the unincorporated areas of the County and within the city limits of St. Augustine Beach.

The Annual Action Plan outlines how the funds will be used for qualifying purposes such as projects, programs, and administration. For the 2025-2026 Fiscal Year, HUD allocated \$1,138,383 for St. Johns County.

The 2025-2026 proposed CDBG Annual Action Plan will provide for the following expenditures:
