By signing hereunder, the Permittee and the group/organization that the signer represents, if applicable, agree to indemnify, defend, and hold harmless St. Johns County and all of its officers, agents, and employees from any claim, loss, damage, cost, charge, or expense arising out of any acts, actions, neglect, or omission by the Permittee, its agents, employees, or subcontractors, during the event proposed or during the performance of the Contract to which this closing/special use relates, whether direct or indirect, and whether to any person or property to which St. Johns County or said parties may be subject, except that neither the Permittee nor any of its subcontractors will be liable under this Article for damages arising out of the injury or damage to persons or property directly caused or resulting from the SOLE negligence of St. Johns County or any of its officers, agents or employees.

Permittee's obligation to indemnify, defend, and pay for the defense or at St. Johns County's option, to participate and associate with St. Johns County in the defense and trial of any damage claim or suit and any related settlement negotiations, shall be triggered by St. Johns County's notice of claim for indemnification to Permittee. Permittee's inability to evaluate liability or its evaluation of liability shall not excuse Permittee's duty to defend and indemnify within seven days after such notice by St. Johns County is given by registered mail. Only an adjudication or judgment after highest appeal is exhausted specifically finding St. Johns County SOLELY negligent shall excuse performance of this provision by Permittee. Permittee shall pay all costs and fees related to this obligation and its enforcement by St. Johns County. St. Johns County's failure to notify Permittee of a claim shall not release Permittee of the above duty to defend.

It is understood and agreed that the rights and privileges herein set out are granted only to the extent of St Johns County's right, title, and interest in the public road right-of-way or land to be entered upon and used by the Permittee, and the Permittee will, at all times, assume all risk of and indemnify, defend and save harmless St. Johns County from and against any and all loss, damage, cost, or expense arising in any manner on account of the exercise or attempted exercises by said Permittee of the aforesaid rights and privileges.

During the event, all safety regulations of St. Johns County shall be observed and the holder must take measures, including placing and display of safety devices, that may be necessary in order to safely conduct permitted event in accordance with the Federal Manual on Uniform Traffic Control Devices (MUTCD), as amended, and the Florida Department of Transportation's latest Roadway and Traffic Design Standards.

In case of non-compliance with St. Johns County's requirements in effect as of the approved date of this permit, this permit will be considered void and the event will have to comply or St. Johns County reserves the right to revoke any such use immediately, or in the case of a Contract, the facility will have to be brought into compliance or removed from the R/W at no cost to the St. Johns County.
