# PROVIDERS & SERVICES

## Suite 101 - Youth Crisis Center *Open now*

Short-term counseling for youth ages 6-17 (Family Link) and their families. Stop Now and Plan (SNAP®) services include 13 weeks of skills-based group sessions for youth ages 6-11 who have behavioral concerns. Services include the parents/guardians and are at no cost to families.

## Suite 102 - First Coast YMCA *Open February 1st*

Access to open gym with new multi-functional equipment, educational health programs, Silver Sneakers, and group fitness classes through income-based membership options.

## Suite 201 - UF Health St. Johns *Open Spring 2026*

Full-service primary care clinic offering full range of medical services for all ages including routine checkups, chronic condition care, and preventive medicine. Medicare, Medicaid, and most commercial insurance plans accepted.

## Suite 202 - EPIC Behavioral Healthcare *Open February 1st*

Outpatient mental health, substance use disorder, and psychiatric services, peer support, and Rapid Response. Most commercial insurance plans accepted, Medicaid, and self-pay with sliding scale, and grant funds available.

## Suite 202 - Wildflower Clinic *Open February 1st*

Free medical care including primary and chronic condition care, diagnostic testing, women's health and prenatal care, and vision screening, for un-insured and income eligible adults.
